

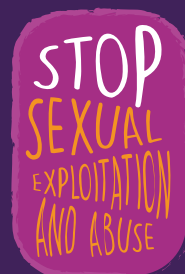


Progress of UNFPA Venezuela

Introduction

The UNFPA Executive Director Dr. Natalia Kanem assumed the Inter-Agency Standing Committee PSEAH Championship in January, 2021; She established 03 priorities during her championship:

- 1) Bolstering PSEA Country Mechanisms;
- 2) Improving Victim Access to Quality Information and Assistance; and
- 3) Strengthening Coordination and Cohesion.

Venezuela was one of the 35 priority countries identified to improve access to quality information and assistance for SEA survivors.

To comply this, each country was asked to carry out the following activities:

- 01 dedicated UNCT Meeting on PSEA and the Championship
- 10 Community conversations on PSEA
- 10,000 people reached with information



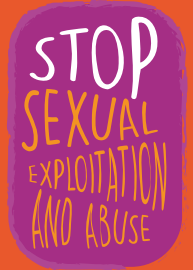

BOLSTERING PSEA COUNTRY MECHANISMS

During this year, an interagency contact line for beneficiaries was established in Zulia state. This AAP and PSEA pilot is expected to be replicated in other states of the country. It is worth mentioning that the contact line is planned to become a nation wide PSEA interagency reporting mechanism during the first quarter of 2022.

It's important to mention that UNFPA has a key role in developing informative materials for the communities. The contact line operators have been trained by UNFPA and the PSEA Network to handle GBV and SEA related calls.

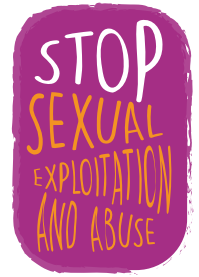
Likewise, UNFPA has been working on Implementing Partner assessment on PSEA, at the end of the year all UNFPA's IPs achieve Full Capacity. This process is also allowing UNFPA to contribute to the mapping of existing PSEA reporting mechanisms in country.

IMPROVING VICTIM ACCESS TO QUALITY INFORMATION & ASSISTANCE

The PSEA Interagency Protocol for the reception of complaints has been updated. The AoR of GbV and the PSEA network has been working on referral pathway and service mapping, which ensure that SEA victims are safely and effectively referred to the GBV services.



STRENGTHENING COORDINATION AND COHESION



UNFPA is part of the PSEA Interagency Network, currently leading the group. The network is composed of all agencies with a presence in Venezuela, members of the CCTs and some local and international NGOs, a total approximate of 20 focal points, who meet on a monthly basis.

Annually, the network designs a work plan. In 2021, UNFPA contributed with the objective related to communications with communities.



PROGRESS ON ADVOCAY CAMPAIGN

ONE DEDICATED UNCT MEETING ON PSEA AND THE CHAMPIONSHIP

At the beginning of the year, the PSEA Interagency Network Coordinator had a meeting with the UNCT about the annual work plan, however, there were several changes inside the UNCT, including the Humanitarian Coordinator and PSEA Coordinator.

All year, the PSEA Interagency Network continued their activities with UNFPA temporary leadership. UNFPA ensured that all agencies's focal points were designated, also strengthened the interagency protocol and indicators.

The last trimester, the new Humanitarian Coordinator and PSEA Interagency Network Coordinator arrived in the country (UNFPA maintains leadership).

We requested the UNCT dedicated meeting, but before that the new Humanitarian Coordinator decided to carry out a survey to Staff and Implementing Partners about PSEA knowledge and complaint mechanisms, He also encouraged all Representatives to demand PSEA online training for all staff.

The information collected will be used as part of the UNCT dedicated meeting, **we expect to have this discussion in January, 2022.**

PROGRESS ON ADVOCAY CAMPAIGN

10 COMMUNITY CONVERSATIONS ON PSEA

Our Implementing Partners were deeply involved in the Advocacy Campaign, they celebrated twenty-nine (29) conversations with key populations in Apure, Bolívar, Táchira, Zulia and Carabobo.

In these states they had the opportunity to share information about PSEA to migrant women, community leaders, girls and adolescents, indigenous people, etc.

We designed a special presentation adapted to these publics and printed materials, such as flyers, stickers and informative cards.

PROGRESS ON ADVOCAY CAMPAIGN

AT LEAST, 10,000 PEOPLE REACHED WITH INFORMATION

People were reached with PSEA information mainly through social media, however, PSEA key messages were included in all activities, such as training, sensitization days, door to door activities, etc.

Considering both strategies we reached:

On social media 18,631

Other activities 80,818 ♀ 69,001 ♂ 11,817

Total **99,449** people

CHALLENGES ENCOUNTERED

The new Humanitarian Coordinator has been very supportive in promoting PSEA; we hope that efforts will continue in 2022 and the PSEA Interagency Network gets even stronger. Next year, will be focused on training for new focal points, ensure that all Implementing Partners have full capacity on UN PSEA Protocol and also strengthen the complaint mechanisms.

It is necessary to have more materials and key messages in Spanish, the office translated many documents into Spanish to ensure that the Implementing Partners and members of the communities understood the information. We have pending the adaptation of materials to indigenous languages and some populations with disabilities.

The branding image was a great asset, but a recommendation, for future campaigns it's important to share vector files and develop illustrations useful for the design of local materials.
